# League emphasizes importance of voting

Elections are not decided by polls. Elections are decided by people. It may be tempting to think “It’s too much trouble,” or “My vote doesn’t really count,” or “According to all the polls, my candidate is going to (win, lose) anyway, so why bother?” But, we know that polls can be manipulated. Voters can change their minds. Upsets can happen.

People who decide elections—voters—are citizens of the United States age 18 and older. All such citizens have the responsibility to exercise the right to choose those who will govern. The League of Women Voters actively promotes every eligible citizen to register and vote on Election Day or before. Texas law allows for early voting and voting by mail for those unable to go to the polls on Election Day.

Women seem to take this responsibility the most seriously, probably because they were not allowed to exercise the right to vote until 1920. In every election since then, women have cast more votes than men in the majority of local, state and national elections. The League was born out of the suffragettes who protested, picketed the White House and other venues, and were imprisoned for doing so for years before 1920.

Since its inception, the LWV has maintained its mission of “a nonpartisan, political organization that encourages informed and active participation in government, works to increase the public understanding of major political policy issues, and influences public policy through education and advocacy.”

In 1964, the League of Women Voters of Texas was influential in repealing the Texas poll tax, which was a barrier that prevented minority citizens from voting. In recent years at the national, state and local levels, the League of Women Voters has opposed Voter ID laws that would result in disenfranchisement of potential voters. This year, LWV-Corpus Christi, organized

in the mid-1940s, undertook a nonpartisan VOTE 18 Project with community partners to educate and register new voters not only in high schools located in precincts with low voter turnout, but also at Del Mar College and TAMU-CC. Over 800 new voters were added to the list of registered voters in Nueces County.

Before the election LWV-CC distributed its latest Voters Guide throughout the city to government buildings, libraries and frequently visited public places. An important educational activity of the League, the Voters Guide provides information on candidates and their positions—furnished by the candidates themselves—to assist registered voters in making informed choices about the candidates.

In addition to the local Voters Guide, LWV-Texas produced a Voters Guide that featured state races. Electronic versions of both Voters Guides are available at the local League website [www.lwv-cc.org](http://www.lwv-cc.org) and on its Facebook page, at “Corpus Christi League of Women Voters.”

Throughout the United States, League members are working to create a culture that values voting by sharing information, providing education and encouraging others to exercise this precious and fundamental right of citizenship. LWV-CC members are a diverse group of women and men who believe strongly that the foundation of our government at all levels is “of the people, by the people and for the people.”

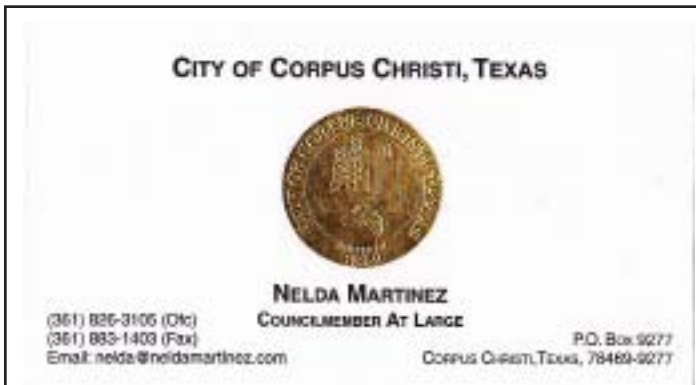

Generally, state program changes are made during our convention in even-numbered years. However, the bylaws provide for changes to be made at a statewide conference with at least half of the local Leagues represented. The state board has voted to call a statewide conference in conjunction with Lobby Days to consider a recommended change to our redistricting policy.

The change would remove the reference to communities of interest in the redistricting position. The current position states, "Criteria for drawing district boundaries include the following ... consideration should not be given to retention of incumbents, political party strength, or to communities of interest." (See the complete position statement in Program Perspectives 2012-2014 on the LWV-TX website.) The change is recommended to conform to the LWVUS position. Additional information will be provided prior to the conference

Lobby Days. We will have outstanding speakers on Monday afternoon and leave Tuesday morning for lobbying. On both occasions we will be in the capitol, very similar to the last Lobby Days.


