# President's Message

LWV-Texas does a remarkable job of keeping up with bills filed and their progress through the Texas legislative process. Issue Chairs and Capitol Corps members deliver testimony, provide

witness registration for and against bills, add to the research on issues, check facts with current League positions, and keep up with who does what, where and when. Best use of volunteer time and resources is frequently undermined when hearings are called on short notice, which happens way too frequently!

The latest League Legislative Newsletter was published April 19 and I encourage local members to go on the LWV-Texas website to review the content. As reported by Laura Blackburn, Advocacy Vice President, here are a few areas of note:

SJR (Senate Joint Resolution) 1: proposes a constitutional amendment providing for the creation and use of funds in the state treasury to provide financial assistance for certain projects related to economic development and water infrastructure and for the transfer to the funds of money from the economic stabilization fund. What that means is taking money from the Economic Stabilization Fund —better known as the Rainy Day Fund—and putting it into two accounts—one for economic development, primarily transportation infrastructure, and the other for water.

Why a constitutional amendment? The answer seems to relate to the “constitutional spending limit” which will not apply to expenditures explicitly dedicated in the state’s Constitution. Should this pass, the League will be involved in preparations at the local level for another election. Many support the Rainy Day Fund as a source of much needed funds for education and

the high cost of health-related state expenses that continue to plague our state. “Thoughtful amendments” in those areas may be considered by Senator Tommy Williams, Chair of the Senate Finance Committee.

I suspect there is a relationship between the 3.5 billion from the Rainy Day fund for economic development and the cries for help from local jurisdictions in areas of the state undergoing the industry of fracking. The increase in traffic in these areas by trucks hauling their wares is adding insult to streets, roads and bridges—aging infrastructure at best—with no local funding means to address needed repairs and maintenance. The allocation is proposed in the form of loans to political subdivisions, thus avoid looking like a subsidy to offset costs of private industry responsibility. League Priority Issues: Education —again underfunded by \$2.9 billion just to get back to square one, but at least an amendment to the budget bill opposing vouchers by Rep. Abel Herrero passed. Health Care—Medicaid continues to be at the top of the list with no position from our Governor. Good and legislation is proposed for managed care, health care for those of lesser means and older Texans, services for people with behavioral health needs, child health care and reproductive choice/women’s health. Water—s being closely watched in the proposed Constitutional Amendment, along with two competing bills on changing the administrative organization of Texas Water Development board.

Once you review the information provided, the League member listed as the contact person for that issue area is the contact for an update. You are encouraged to contact your representative and senator in support of League positions.

Remember: if your personal opinion differs from that of the League position, you must refrain from voicing an opposing opinion as a League member.

## Members attend RESTORE meeting

### Hearing concerned allocation of funds from BP oil spill penalties

League of Women Voters – Corpus Christi Area members were among the large number of concerned citizens attending the initial regional public meeting on the British Petroleum Deepwater Horizon oil spill of 2011. Held April 10, the hearing was led by Corpus Christi Mayor Nelda Martinez in an open process of public input to aid the City in facilitating a plan to address regional environmental, economic development, and community needs of the Coastal Bend.

The RESTORE (Resources and Ecosystems Sustainability, Tourist Opportunities, and Revived Economies of the Gulf Coast States) Act of 2012 dedicates 80 percent of Clean Water Act civil and administrative penalties from the Deepwater Horizon oil spill to the Gulf Coast Restoration Trust Funds. Although uncertainty exists around the ultimate amount and timing of funds, \$1 billion in civil penalties is currently available.

In addition to allocation of funds, the RESTORE Act establishes a Gulf Coast Ecosystem

Restoration Council responsible for developing an initial comprehensive plan. Based on public input, the plan will include:

- provisions to incorporate task force strategy
- list of projects or programs authorized prior to enactment of the RESTORE Act, but not yet begun
- description of how funds will be allocated by the Council for the next 10 years
- 3-year project and program priority list based on criteria included in the RESTORE Act.

Overarching goals are to restore and conserve habitat, restore water quality, replenish and protect living coastal and marine resources, enhance community resilience, and restore and revitalize the Gulf economy.

The timeline for the initial comprehensive plan development includes public engagement opportunities in the Gulf states, a draft initial comprehensive plan and 30-day public comment period, with Initial

Comprehensive Plan release in July.

The Mayor's office, in hosting the initial meeting, invited input from the public on long-term outcomes, types of projects for consideration, and future public participation opportunities. Several local environmental groups suggested projects, some under development without funds, such as the Cole And Ropes Park (CARP) initiative. Sandra Heatherley provided information about that project. President Judy Telge spoke to the alignment of the League with good environmental stewardship as represented in several of the local projects and with the goals of the RESTORE Act. LWV-CC members Elena Buentello and Andrew Dimas were involved in the meeting as City Planners.

City of Corpus Christi Planning and Environmental Services is coordinating the City's initiative. Comments must be received no later than 5 p.m. on May 17 to:

# Cole and Ropes parks public meeting Committee's goal is reducing bacteria in bay

Several Local League members were in attendance on Monday evening, April 22, for the public meeting regarding proposed actions that are designed to reduce the bacterial content of bay waters adjacent to Cole and Ropes parks.

The concern is for the public's health and possible disease when playing in and perhaps ingesting the water.

The meeting was called and conducted by the committee formed because the Texas General Land Office and the EPA's Beach Watch program have deemed the beaches at the two parks as "not supporting" recreational marine beach use 25 percent or more of the time.

The concern is for the public's health and possible gastrointestinal disease when playing in and perhaps ingesting the water.

The committee has identified eight stakeholder groups including business, tourism, recreational users and homeowners and created four workgroups including, city infrastructure, education and outreach, science and technology, and ordinance and regulation.

The purpose of the public meeting was for the workgroups to share the implementation strat-

egies which have been developed as possible means of reducing the bay's bacteria.

The workgroups used large poster displays placed around the room so that the public attendees, about 40 of them, could move from poster to poster to hear the activities that each work group is proposing.


The list of activities is too long to present here and included ideas such as; conducting storm water outflow sampling, evaluating the sources of the bacteria down to the species responsible for the pollution, preventing intentional wastage or dumping, improving sanitary sewer overflow reporting, code updates for residential and business properties.

After hearing each presentation the attendees were given a "public comment" card on which to write new ideas, improve or dispute the ideas presented, and volunteer to participate in the process.

The finale of the meeting was the presentation by Sally Farris, League member and retired environmental attorney, who emphasized the importance of our beaches as "natural treasures" and asked the community to "keep the discussion alive and maybe we can effect change".

The Implementation Committee is currently reviewing the comments for discussion at future committee and workgroup meetings. 
