President's Message

LWV-CC accomplished several major tasks these past 11 months. The League set goals to achieve before December 31, 2016 — goals that would increase membership involvement, increase new voter registrants, increase voter participation on November 8, 2016, and forge new partners with organizations.

League membership is currently at 128 and due to member volunteer efforts, 3,139 new voters were registered between January and October 11, 2016. The League worked to make Vote Centers a reality in Nueces County. The League hosted two forums that yielded standing room only participation and a monthly meeting that focused on informing our community about candidates, propositions, and bond proposals.

In addition, the League worked to provide information with English and Spanish Voter Guides and VOTE411.org. League members worked to engage 50% of the registered voters to cast an informed vote on November 8.

League members also participated in reaching out to 3000 voters via Robo-calls and one-to-one telephone banking. The message, "VOTE, VOTE, VOTE."

On Election Day, the League's telephone rang approximately 26 times. Questions ranged from, "Where can I find the city's propositions so I can read before I vote? "Is it true that I can vote at any Vote Center?, "I am in line and it is 6:55 p.m. and there are 28 people in front of me and several behind me, are we going to be able to vote?

At 7:05 p.m., I walked into Nueces County Courthouse and observed the election results being posted. I observed people's reactions from elation, sadness, surprise, disappointment, and anger.

As I drove home at 10 p.m., I thought, "Making Democracy Work" is about engaging people to cast their vote and then observing the process at work.

No matter the results of this or any election, LWV-CC remains resolute. The more people vote, the more attention they receive from those elected. Every election has winners and losers, but the true winners are those who cast an informed vote.

As a League, we thank everyone who registered and voted. Now it is time to move forward and focus on the 2017 Texas Legislative Session which is scheduled to begin on January 10, 2017, as well as on city issues that are identified for LWV-CC study.

Voter Services at Work

LWV-CC Voter Services volunteers have been working tirelessly this season. In addition to registering record numbers of new voters, LWV-CC hosted two standing-room-only candidate forums on October 13 and October 20, 2016.

The LWV-CC October Monthly meeting focused on the proposed bond proposals by Del Mar College and Corpus Christi ISD. Presenters included Dr. Roland Hernandez, CCISD Superintendent; Claudia Jackson, DMC Vice President for Public Affairs; and Trey McCampbell, President of the DMC Board of Regents. They also responded to questions from attendees.

LWV-CC volunteers distributed a local 28-page Voters Guide as well as the LWV-Texas English and Spanish Voters Guides throughout the city and county and also populated VOTE411 with local candidate information.

Voter Services coordinated the LWV-CC Telephone Bank Outreach Program that reached approximately 6,000 Nueces County registered voters. LWV-CC members recognize the importance of providing information prior to casting an informed VOTE.

At the annual LWV-CC Annual Meeting held last May, one of the League's goals was to increase voter participation in Nueces County to at least 50% of the registered voters. The data below illustrates that the goal was achieved. By working as a TEAM with other organizations, much can be achieved. Thank you,


